## Terms and conditions

1. It is agreed that the terms set out in this booking form is the total agreement made between the parties and that no variation or modification of this contract shall be effective unless agreed by both parties in writing via e-mail or letter.

### 2. Special Requests/Coverage

The client understands and accepts that the photographic coverage will be as the photographer's professional expertise determines and that no one photograph will be deemed more important than another. Special requests are not binding instruction, although every effort is made to comply with the client's wishes.

3. Any special requests not notified on this booking form or on the photography coverage form must be made by the client to the photographer/s in writing.

### 4. The Photographer/s

On occasions and without notice it may be necessary for the photographer/s originally specified to be substituted by another photographer/s, (e.g. due to ill health).

### 5. Images

All image sizes are nominal. The photographer/s will provide a pleasing colour balance but cannot guarantee exact colour matching owing to anomalous reflectance caused by a combination of certain dyes and materials especially man-made fibres. It is sometimes impossible to record on film the exact colour seen by the human eye.

### 6. Retouching

Retouching, digital manipulation and artist finishing will be completed as we deem necessary.

### 7. Copyright

Any images or copies of images whether stored digitally or otherwise and any computer program including any source or object code, computer files or printed documentation relating to such images are protected by Copyright and Design Act 1988. It is contrary to the Act to copy or allow to be copied photographically/ electronically or by any other means an image created as part of this contract without the permission of the photographer/s in writing. We give you the right to print any photograph from the disc we supply you for personal use only; e.g. display in your own home or on online social networking site such as 'Facebook' for personal use only as long as you credit the photographs to us (FfocalPoint Photography). Commercial usage is not permitted.

### 8. Negatives/Digital Files

Negatives/Digital files remain the property of FfocalPoint Photography; the photographer/s.

### 9. License

The photographer/s shall be granted complete artistic license including in relation to the poses photographed and the location used. The photographer/s judgment regarding the locations/poses and number of images taken shall be final. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the images requested.

### 10. Force Majeure or Act of God

The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

### 11. Photographs

Although the photographer/s will do their best to produce more photographs than set out in the brochure and on their website or as discussed with the client, there is no guarantee that any particular number of photographs will be produced.

### 12. Display

The client hereby allows the photographer/s to display any images included in this contract in their studios, offline and online portfolios, literature, wedding exhibitions and advertising.

### 13. Cancellation

The client/s may cancel this contract at any time by giving written notice to the photographer/s but in doing so shall forfeit any monies paid. Should cancellation be received by the photographer/s less than four weeks prior to the date of the ceremony, the client shall in addition pay a sum equal to 20% of the remaining contract value. The said sum shall be payable as compensation as an estimate of the loss the photographer/s would suffer.

### 14. Limitation of Liability

In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

### 15. Complaints

Any complaints should be raised by the client with the photographer/s in writing, within 28 days of first becoming aware of the matter to be complained of and in any event within 28 days of receipt of images.

### 16. Discounts and voucher codes

If you have a voucher code, the discount will be applied to your final balance. Only one discount / voucher code can be applied to any one booking.
